These options include safe mercury amalgam removal, biocompatible periodontal therapy, and restorative dentistry that utilizes nonreactive dental materials. Dr. McGrath follows the amalgam removal protocol (SMART) prescribed by the International Academy of Oral Medicine and Toxicology (IAOMT), an organization which supports the principles of biological dentistry.

Starting with the initial assessment, patients gain the knowledge that a dentist can have a great impact on their overall health: the identification and treatment of infection, the placement of biocompatible restorative materials, and the creation of a healthy occlusion (impacting the overall craniosacral alignment of the body). The practice has evolved to include the latest diagnostic techniques, and collaboration with a large network of health professionals. .

In response to research findings connecting systemic illness to periodontal disease, Dr McGrath and his hygiene team developed an antibacterial periodontal therapy program. Periodontal scaling and root planning with in-office ozonated water irrigation are the foundations of the soft tissue management program. The regular use of a phase-contrast microscope with oral bacterial slides is a part of the periodontal treatment and maintenance plan.

Patients coming to this practice are wellness focused and interested in dentistry that supports their overall health goals. Comprehensive and individualized treatment plans are developed for each patient. The treatment plans ensure that the patient's dental goals are achieved beautifully, using the best biocompatible materials. It is a strong emphasis of the practice to provide occlusal rehabilitation and cosmetic dental services to patients. Thus the treatment plans range from a single crown to full-mouth reconstruction.

In 1968 Dr. McGrath graduated from the University of Buffalo Dental School. He is an accredited member of the International Academy of Oral Medicine and Toxicology and a Fellow in the Academy of General Dentistry. He maintains active memberships in The International Association of Mercury Safe Dentists, The International Academy of Biological Dentistry and Medicine, and The Holistic Dental Association.

Through the years of practice, Dr. McGrath has become very conscious of the link between optimal dental health and overall well-being. As a result he has devoted his career to practicing healthy non-invasive, biocompatible dentistry. In 1984, he discontinued the use of dental amalgam, and adopted safe mercury removal protocols for patients, caregivers, and the environment. A biological approach to dental treatment has been the backbone of the practice for over thirty years.
